3. HAZARDS IDENTIFICATION

Flammability

Flammable: Flash point = 52 °C (closed cup)

Potential Health Effects

Skin contact: May cause irritation.
Eye contact: May cause irritation.
Inhalation of spray or mist: May cause nasal, throat, or lung irritation.
Inhalation of large amounts: May be toxic to the lungs.

Symptoms:

May be modest initially, followed in hours by severe shortness of breath requiring prompt medical attention.

Carcinogenicity Information:

None of the components present in this material at concentrations equal to or greater than 0.1 % are listed by IARC, NTP, OSHA or ACGIH as a carcinogen.

4. FIRST AID MEASURES

Inhalation:

If inhaled, remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Call a physician.

Skin Contact:

Flush skin with water after contact. Wash contaminated clothing before reuse.

Eye Contact:

In case of contact, immediately flush eyes with plenty of water for at least 15 minutes. Call a physician.

Ingestion:

If swallowed, do not induce vomiting. Immediately give 2 glasses of water. Never give anything by mouth to an unconscious person. Call a physician.

Note to Physicians:

Activated charcoal mixture may be administered. To prepare activated charcoal mixture, suspend 50 grams activated charcoal in 400 mL water and mix thoroughly. Administer 5 mL/kg, or 350 mL for an average adult.

5. FIRE FIGHTING MEASURES

Flammable Properties

Flash point:

52 °C (closed cup)

Hazardous Decomposition Products:

Hazardous decomposition products include carbon dioxide, carbon monoxide, and hydrogen fluoride. Toxic gases or particles may be formed during combustion. These products may cause severe eye, nose, throat, and lung irritation or toxic effects.

Extinguishing Media:

Water spray, foam, dry chemical, CO₂.

Fire Fighting Instructions:

Evacuate personnel to a safe area. Keep personnel removed and upwind of fire. Wear self-contained breathing apparatus. Wear full protective equipment. Avoid breathing decomposition products.

Safeguards (Personnel)

Mark-out the contaminated area with signs and prevent access to unauthorized personnel. Turn leaking containers leak-side up to prevent the escape of liquid.
Environmental Precautions:	Do not discharge into drains or rivers. Contain the spillage using bunding.
Clean-Up Procedures:	Absorb into dry earth or sand. Transfer to a closable, labeled salvage container for disposal by an appropriate method.

8. HANDLING AND STORAGE

Handling Requirements:	Avoid direct contact with the substance. Ensure there is sufficient ventilation of the area. Do not handle in a confined space. Avoid the formation or spread of mists in the air. Only use in a fume hood.
Storage Conditions:	Store in a cool, well-ventilated area. Keep container tightly closed.
Suitable Packaging:	Must only be kept in original packaging.

9. EXPOSURE CONTROLS AND PERSONAL PROTECTION

Engineering Controls:	Keep container tightly closed. Use only with adequate ventilation. Vent heated extruder or dryer fumes outside work area. Do not aerosolize. In spray applications, use airless type pressure spray equipment at less than 60 psi, and exhaust ducts, drip pans, or other design features to minimize worker exposure to mists and overspray.
Personal Protective Equipment	
Eye/face protection:	Wear safety glasses. Ensure eye-wash is at hand.
Respirators:	Self-contained breathing apparatus must be available in case of emergency.
Protective clothing:	Where there is potential for skin contact, have available and wear as appropriate impervious gloves, apron, pants, and jacket.
Hand protection:	Protective gloves.
